Passes must be visible on all ensemble members at all times while on Festival grounds. Those without their passes will be required to pay the normal entrance fee to enter. ## Entertainment Selection:

MacDudley's RenniMas + Naughty Bawdy Bodacious Xmas Show is not only a fun, family-friendly event, it is also an educational experience for guests. It is important that all entertainment ensembles look and behave as period as possible. All new Entertainers or past Entertainers who have new acts should submit pictures and videos of their act along with their application. Videos may be submitted on CD/DVD or as links to video sites on the internet (i.e. YouTube, Facebook). Please, DO NOT e-mail the videos themselves. Local acts (school groups, community groups, etc.) should provide a very detailed description of your anticipated costuming and performance as a minimum. The entertainment selection committee at MacDudley Dragon Entertainment LLC. will review all applications for appropriateness and entertainment value.

## Additional Rules and Guidelines

- 1) **Alcohol:** Alcohol is not permitted on festival grounds at any time outside of the pub.
- 2) **Smoking:** Local laws do not allow smoking in the arena
- 3) **Spiritualism:** We at MacDudley Dragon Entertainment LLC respects and honors all religious beliefs. MacDudley Dragon Entertainment LLC will not tolerate religious discrimination of any kind.
- 4) **Politics:** To keep things light-hearted, merchants and merchandise promoting political agendas are not allowed.
- 5) **Customer Filching:** No merchant may knowingly lure festival guests away from any other merchants or show.
- 6) **Children:** All children 16 and under ALWAYS need to be accompanied by an adult , no exceptions.
- 7) **The Show Goes On:** MacDudley's RenniMas & Naughty Bawdy Bodacious Xmas Show will run regardless of the weather. Be sure to have an alternative means of transporting your available goods.
- 8) **Family Friendly:** This is a family event during 10 am to 7 pm. Wardrobe and speech should be rated "G", for all audiences. Our audience will also consist of people with different disabilities so please be a little more understanding with them.
- 9) **Stay in Character:** At any time when you are interacting with guests, try to stay in character with the theme of the event. Your voice, dress, products and booth should help immerse attendees in the event. however ensembles are solely responsible for their own equipment.
- 10) **Taxes:** All Entertainers are responsible for payment of Michigan State Sales Tax where appropriate.
- 11) **Insurance:** A certificate of liability insurance is required of all Entertainers or perform demos that pose a potential danger to our guests (i.e. swords, toy weapons, food, etc.). This coverage, for no less than \$250,000, should name MacDudley Dragon Entertainment LLC. 4304 Winthrop ave. Portage, MI 49002. Insurance must be verified prior to the event otherwise the entertainer may not set up and all monies paid to the Event will be forfeited. Determination of this requirement is made by MacDudley Dragon Entertainment LLC so be sure to ask if you have questions.
- 12) **Security:** Security is on site during event hours; however, merchants are solely responsible for their own booth and merchandise.
- 13) **Marketing:** All submitted pictures (CD's) become the property of MacDudley Dragon Entertainment LLC and may be used for marketing purposes
- 14) **Animals:** Only service animals for the disabled are allowed. Animals that are part of a performance or demonstration are allowed with pre-approval. Vaccination history is required.
- 15) **Vending area:** This is an indoor event. So, there is no need for pop-ups or stakes of any kind. You can either prove your own tables and chairs or rent them from us. Please provide appropriate table covers.
